### INTELLECTUAL PROPERTY TRANSFER AGREEMENT

THIS INTELLECTUAL PROPERTY TRANSFER AGREEMENT, effective as of July 31, 2015 (this "Agreement"), is by and between THE FRS COMPANY, a Delaware corporation (the "Seller") and FRS INTERNATIONAL AG, a Swiss Atkiengesellschafft (the "Purchaser"). Capitalized terms used but not otherwise defined herein shall have their respective meanings given to such term in that certain Asset Purchase Agreement, dated as of July 31, 2015 (the "Asset Purchase Agreement"), by and among the Seller and the Purchaser.

WHEREAS, pursuant to the Asset Purchase Agreement, Seller has agreed to assign to Purchaser all of its right, title and interest in the Business Intellectual Property as defined in the Asset Purchase Agreement, and this Agreement effects the foregoing.

WHEREAS, the execution and delivery of this Agreement is a condition to the obligations of the parties to consummate the transactions contemplated by the Asset Purchase Agreement.

**NOW, THEREFORE**, in consideration of the foregoing and the mutual agreements and covenants set forth herein and in the Asset Purchase Agreement, the Purchaser and the Seller hereby agree as follows:

- 1. <u>Assignment.</u> Subject to the Closing of the APA, Seller hereby irrevocably assigns and conveys to Purchaser, all of Seller's worldwide right, title and interest of whatever nature in and to the Business Intellectual Property.
- 2. <u>Transfer</u>. Seller shall take all actions deemed reasonably necessary by Purchaser to facilitate and further memorialize and effect the assignment and conveyance of the Business Intellectual Property to Purchaser described in Section 1 herein. This may include, without limitation, Seller's reasonable cooperation with Purchaser to file and process all forms, instruments, agreements and other formalities necessary to complete the transfer of all the Business Intellectual Property to Purchaser. Purchaser shall be responsible for any and all expenses including legal fees incurred pursuant to this Section 2.
- 3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this Agreement is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Purchaser with respect to the Business Intellectual Property. The representations, warranties, covenants and agreements contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.
- 4. <u>Counterparts</u>. This Agreement may be executed and delivered (including by facsimile transmission or by means of portable document format (pdf sent via email) in counterparts by the parties hereto, each of which when executed shall be deemed to be an original, and all of which taken together shall constitute one and the same agreement.

5. <u>Governing Law</u>. This Agreement shall be governed by, and construed in accordance with the laws of Switzerland applicable to contracts executed in and to be performed in that canton and country, regardless of the residency of the parties hereto or the location of the Assets and without regard to any conflicts of law principles.
