TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (“*Termination and Release*”) is granted as of September 15, 2015 by **WELLS FARGO CAPITAL FINANCE, LLC**, as Agent (as successor by merger with Wells Fargo Foothill, Inc.) (the “*Agent*”), in favor of **MONOTYPE IMAGING HOLDINGS CORP.**, a Delaware corporation, **INTERNATIONAL TYPEFACE CORPORATION**, a Delaware corporation, **MONOTYPE IMAGING INC.**, a Delaware corporation, **LINOTYPE CORP.**, a Delaware corporation, and **IMAGING HOLDINGS CORP.**, a Delaware corporation (collectively, the “*Grantors*”);

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement dated as of November 5, 2004 (the “*Foothill Trademark Security Agreement*”) granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein (the “*Foothill Marks*”);

WHEREAS, the Foothill Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on November 8, 2004, at Reel 2975, Frame 0530;

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement dated as of July 13, 2011 (the “*2011 Capital Finance Trademark Security Agreement*”) granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein (the “*2011 Capital Marks*”);

WHEREAS, the 2011 Capital Finance Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on August 18, 2011, at Reel 4607, Frame 0265; and

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement dated as of April 9, 2012 (the “*2012 Capital Finance Trademark Security Agreement*”) granting the Agent a security interest in and lien on certain trademarks and trademark applications described therein (“*2012 Capital Finance Marks*”; together with the Foothill Marks and the 2011 Capital Marks, the “*Marks*”);

WHEREAS, the 2012 Capital Finance Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on June 12, 2012, at Reel 4799, Frame 0509; and

WHEREAS, the Grantors have requested that the Agent provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby releases and discharges its liens and security interests in the trademarks and trademark applications identified on Schedule I.
