1. They are the President and Secretary, respectively, of PNI Corporation, a California Corporation (the "Corporation").
2. Article I of the Amended and Restated Articles of Incorporation of the Corporation is amended to read as follows:


"ARTICLE I: The name of this corporation is PNI Sensor Corporation."

3. The foregoing Amendment of Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is as follows: 6,859,248 Common Stock; 637,276 Series A Preferred Stock; 3,947,276 Series B Preferred Stock; and 849,739 Series C Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding shares of each class of stock.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
