- 2. Assignor hereby agrees to execute, acknowledge and deliver any and all documents and to take such other and further actions as are reasonably necessary to transfer and assign the Mark to Assignee, and to make a record of such assignment, including, without limitation, recording this Assignment with the United States Patent and Trademark Office and recording the change of ownership at the World Intellectual Property Organization, as appropriate.
