THIS DEED is made the 29th day of December 2014

BETWEEN:

- (1) SANDALS RESORTS INTERNATIONAL 2000 LIMITED, a company registered in the Bahamas whose registered office is located at Caves Village, Building 10, Office 2, West Bay Street, Nassau, Bahamas (the "Assignor"); and
- (2) SANDALS RESORTS INTERNATIONAL 2000 INC., a company registered in Panama whose registered office is located at España Avenue, and Aquilino De La Guardia St Ner. 1, Beta Building, Post Office Box 0823-04699 Panamá, Republic of Panamá; (the "Assignee").

1. **DEFINITIONS AND INTERPRETATION**

1.1. The following terms shall have the following meanings:

"Assigned Rights" means the Trade Marks, Copyright in the Works and Domain Names.

"Copyright" means in relation to any work all copyright in that work being:

- (i) the exclusive right to do and to authorise others to do in relation to that work any and all acts restricted by Part 1 of the Copyright, Designs and Patents Act 1988 as amended from time to time, or by any statute replacing it or any part of it, in the United Kingdom;
 - (ii) all rights of a similar nature to those described in (i) conferred in relation to that work by the laws in force from time to time in all other parts of the world;
- all for the relevant period of those rights, including any renewals and extensions.

"Domain Names" means all of the domain names owned by the Assignor including but not limited to those domain names set out in Schedule 1 to this Deed.

"Effective Date" means the date of this Deed.

"Trade Marks" means all of the Assignor's trade marks, including but not limited to the registered trade marks, applications and unregistered trade marks, which are set out in Schedule 2 to this Deed.

"Works" means the contents of the www.sandals.com website and the www.beaches.com website and those works set out in Schedule 3 to this Deed.

- 1.2. References to persons include individuals, bodies corporate (wherever incorporated), unincorporated associations and partnerships.
- 1.3. Headings are inserted for convenience only and shall not affect the construction or interpretation of this Deed.

2. **ASSIGNMENT**

- 2.1. As part of an intra-group reorganisation, the Assignor hereby assigns with full title guarantee free from all liens, charges and encumbrances, to the Assignee absolutely and irrevocably all its rights, title and interest in and to the Assigned Rights, including:
- (a) all goodwill attaching to the Trade Marks and Domain Names and in respect of the business relating to the goods or services in respect of which the Trade Marks are used; and
 - (b) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights whether occurring before, on, or after the date of this Deed.
- 2.2. The Assignor hereby irrevocably and unconditionally covenants with the Assignee to execute, at the request and expense of the Assignee at any time on or after the Effective Date, all assignments, deeds, documents, forms and authorisations and to procure the deposing to or swearing of any declarations or oaths and do or procure all other acts and things reasonably necessary or desirable in the opinion of the Assignee to secure unto the Assignee all the right, property and interest agreed to be assigned and transferred under this Deed.

3. **WARRANTIES**

The Assignor warrants and represents to the Assignee as follows:

- (a) it is the sole legal and beneficial owner of, and owns all the rights and interests in, the Assigned Rights;
- (b) it has not licensed or assigned any of the Assigned Rights;
- (c) the Assigned Rights are free from any security interest, option, mortgage, charge or lien;
- (d) it is unaware of any infringement or likely infringement of any of the Assigned Rights;
- (e) so far as it is aware, exploitation of the Assigned Rights will not infringe the rights of any third party;
- (f) the Works are original works and have not been copied wholly or substantially from any other source.

3.2. The Assignor will keep the Assignee fully indemnified against all actions, claims, proceedings, costs and damages (including any damages or compensation paid by way of settlement of any claim) and all legal costs of other expenses arising out of any breach of the above warranties or out of any claim by a third party based on any facts which if substantiated would constitute such a breach.

4. **WAIVER OF MORAL RIGHTS**

4.1. The Assignor shall provide or procure the providing to the Assignee, on or before the date of this Deed, written absolute waivers from all of the authors of the Works in relation to all moral rights which subsist in the Works by virtue of Chapter 4 of the Copyright Designs and Patents Act 1988 and, so far as is legally possible, any broadly equivalent rights such authors may have in any territory of the world.

5. **GENERAL**

5.1. **Entire Agreement**

This Deed sets out the entire agreement and understanding between the parties with respect to the subject matter of it. It is agreed that:

- (a) no party has entered into this Deed in reliance upon any representation, warranty or undertaking of any other party which is not expressly set out in this Deed;
- (b) a party will have no claim or remedy in respect of misrepresentation (whether negligent or otherwise) or untrue statement made by any other party; and
- (c) this clause will not exclude any liability for fraudulent misrepresentation.

5.2. **Variation**

No variation of this Deed will be valid unless it is in writing and signed by or on behalf of each of the parties to it.

5.3. **Severability**

If any provision or term of this Deed shall become or be declared illegal invalid or unenforceable for any reason whatsoever such term or provision shall be divisible from this Deed and shall be deemed to be deleted from this Deed.

5.4. **Waiver**

No failure, or delay on the part of either of the parties to exercise any right or remedy under this Deed shall be construed or operate as a waiver thereof nor shall any single or partial exercise of any right, or remedy preclude the further exercise of such right or remedy as the case may be. The rights and remedies provided in this Deed are cumulative and not exclusive of any rights or remedies provided by law.

5.5. Counterparts

This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts each of which is an original but all of which together constitute one and the same instrument.

5.6. Notices

(a) All notices to be given under this Deed (including approvals, consents and other communications) shall be in writing and shall be sent by first class post or facsimile. However, if either party sends a notice under this Deed by facsimile it shall also send the original notice by post, posted first class within twenty four hours of the transmission of the relevant facsimile. All notices sent by post shall be sent to the address of the other party set out at the commencement of this Deed (or to such other address as either party may notify to the other under the provisions of this clause).

(b) Any notice given under this Deed which is sent:

- (i) by post and which is not returned to the sender as undelivered shall be deemed to have been received two (2) Business Days after posting (if the addressee is in the United Kingdom or four (4) Business Days after posting (if the addressee is outside the United Kingdom);
- (ii) by facsimile shall be deemed to have been received on the date of the transmission.

5.7. No Partnership or Agency

Nothing in this Deed will operate so as to constitute either party as an agent, partner, employee or representative of the other or to permit either party to pledge the credit of the other, to represent itself as being the other party or being an agent, partner, employee or representative of the other party or to hold itself out as such or as having any power or authority to incur any obligation of any nature express or implied on behalf of the other party.

5.8. Contracts (Rights of Third Parties) Act 1999

A person who is not a party to this Deed will have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of its terms.

5.9. Governing Law and Jurisdiction

(a) This Deed and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

(b) The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).
