**TERMINATION OF SECURITY INTEREST  
IN TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS ("Termination of Security Interest") is made effective as of October 14, 2015 (the "Effective Date") by Regions Bank (the "Bank"), in favor of Synergetics, Inc., a Missouri corporation ("Grantor"). All capitalized terms used, but not otherwise defined, herein shall have the meaning set forth in the Loan Agreement or the Trademark Security Agreement, as applicable.

WHEREAS, reference is made to that certain Amended and Restated Loan and Security Agreement, dated December 16, 2014 (the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, Grantor executed and delivered a Trademark Security Agreement, dated as of December 16, 2014, ("Trademark Security Agreement"), for recordal with the United States Patent and Trademark Office and was recorded in the United States Patent and Trademark Office on December 17, 2014 at Reel/Frame 5421/0184, pursuant to which Grantor confirmed its grant to Bank, a continuing security interest and lien in all of Grantor's right, title and interest in, to, and under the Trademark Collateral, whether then existing or thereafter created or acquired (other than Excluded Property).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank agrees as follows:

1. Release. The Bank, hereby releases, discharges, terminates and cancels all of its continuing security interest and lien granted at any time prior to the date hereof in all of Grantor's right, title and interest in, to, and under the Trademark Collateral, whether then existing or thereafter created or acquired (other than any of the following constituting Excluded Property) including without limitation, the trademarks, trademark applications and trademarks licenses set forth on Schedule A.

2. Termination. The Bank terminates and cancels the Trademark Security Agreement.
