#### **GRANT OF SECURITY INTEREST**

WHEREAS, GREATBATCH, INC., a Delaware corporation ("GBI"), GREATBATCH LTD., a New York corporation ("GBL"), NEURONEXUS TECHNOLOGIES, INC., a Michigan corporation ("NNT"), QIG Group, LLC, a Delaware limited liability company ("QIG"), MICRO POWER ELECTRONICS, INC., a Delaware corporation ("MPE") and ELECTROCHEM SOLUTIONS, INC., a Massachusetts corporation ("ESI", and together with GBI, GBL, NNT, QIG and MPE, collectively the "Grantors" and each a "Grantor"), own all right, title and interest in and to the trademarks and servicemarks listed on Schedule A attached hereto, as listed thereon (the "Marks");

WHEREAS, pursuant to a Security Agreement dated as of October 27, 2015 by and among each Grantor, the other Grantors (as defined in the Security Agreement) referred to therein, and MANUFACTURERS AND TRADERS TRUST COMPANY ("M&T"), as the administrative agent (together with its successors and assigns in such capacity, the "Agent") (as the same may be amended, supplemented, restated or otherwise modified or replaced from time to time, the "Security Agreement"), the Grantors have granted to the Agent, for the benefit of the Secured Parties (as that term is defined in the Credit Agreement dated as of the date hereof by and among Greatbatch Ltd., GBI, the Agent and the Lenders referred to therein, as the same may be amended, restated, modified, refinanced or otherwise modified from time to time, the "Credit Agreement"), a security interest in, among other things, all right, title and interest of Grantor in and to the Marks, together with the goodwill of the business symbolized by the Marks and the applications and registrations thereof, and all proceeds thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as that term is defined in the Credit Agreement);

WHEREAS, pursuant to prior security agreements by and among several of the Grantors and M&T, such Grantors have granted to the Agent, security interests in, among other things, all right, title and interest of Grantor in and to certain of the Marks, together with the goodwill of the business symbolized by the Marks and the applications and registrations thereof, and all proceeds thereof (the "Prior Security Interests"); and

WHEREAS, the parties wish to have all such Prior Security Interests assigned to Agent as part of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, each Grantor does hereby grant to the Agent a security interest in the Collateral, and assign the Prior Security Interests to the Agent to secure the prompt payment, performance and observance of the Secured Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
