RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of October 27, 2015 (the "Effective Date"), is made by Goldman Sachs Bank USA, in its capacity as collateral agent pursuant to the collateral agreement (in such capacity, the "Collateral Agent"), in favor of Lake Region Medical, Inc. (f/k/a Accellent Inc.), Venusa, Ltd., MedSource Technologies LLC, and Lake Region Manufacturing, Inc. (collectively, the "Pledgors").

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreement, as applicable.
- 2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in the Trademarks, including the Trademarks set forth Schedule I attached hereto, arising under the Trademark Security Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademarks under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Pledgors, including all the goodwill associated therewith.
- 3. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
