SUPPLEMENTAL GRANT OF A SECURITY INTEREST UNDER THE TRADEMARK SECURITY AGREEMENT

This Supplemental Grant of a Security Interest under the Trademark Security Agreement (the "Supplemental Trademark Security Agreement") is made, and dated as of October 29, 2015 among the Grantors listed on the signature pages hereof (collectively, jointly and severally, the "Grantors" and each individually, a "Grantor") and FSJC II, LLC, in its capacity as Agent for the benefit of the Lender Group (in such capacity, together with its successors and assigns, if any, "Agent"), and supplements the certain Trademark Security Agreement (the "Trademark Security Agreement") dated September 30, 2010, among the Grantors listed on the signature pages thereto in favor of Agent. Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement.

WHEREAS, the Grantors entered into a Security Agreement, dated September 30, 2010 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), in favor of Agent;

WHEREAS, pursuant to the Security Agreement, the Grantors granted to Agent for the benefit of the Lender Group, a continuing security interest in all right, title and interest of the Grantors in, to and under their trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, brand names, certification marks, collective marks, d/b/a's, internet domain names, logos, symbols, trade dress, assumed names, fictitious names, trade names, and other indicia of origin, including, without limitation, the trade names, registered trademarks, trademark applications, registered service marks and service mark applications listed on Schedule 5 attached thereto and made a part thereof and (i) all reissues, continuations, extensions, modifications and renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all Intellectual Property Licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (iii) the right to sue for past, present and future infringements and dilutions thereof, (iv) the goodwill of each Grantor's business symbolized by the foregoing and connected therewith, and (v) all of each Grantor's rights corresponding thereto throughout the world (the "Trademarks"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Grantors entered into the Trademark Security Agreement on September 30, 2010 in favor of Agent;

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 8, 2011, at Reel 4578 and Frame 0250;

WHEREAS, subsequent to the execution date of the Trademark Security Agreement, the Grantors have adopted, used and are using, and hold all right, title and interest in and to, new trademarks and service marks including, but not limited to, those listed on <u>Schedule 1</u> attached hereto, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "New Trademarks"); and

WHEREAS, the Grantors and Agent desire to supplement the Trademark Security Agreement (i) to include the New Trademarks as "Trademark Collateral" thereunder (the "New Trademark Collateral") and (ii) to exclude from "Trademark Collateral" any United States intent-to-use trademark applications prior to the filing of a "Statement of Use" or "Amendment to Allege Use" with

respect thereto, to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration issuing from such intent-to-use trademark application under applicable federal law;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

- 1. <u>Grant of Security Interest in New Trademark Collateral</u>. The Grantors do hereby grant to Agent for the ratable benefit of the Purchasers, a continuing security interest in the New Trademark Collateral (and <u>Schedule 1</u> to the Trademark Security Agreement is hereby amended to include the New Trademarks, which shall be deemed to be "Trademark Collateral" under and as defined therein) to secure the prompt payment, performance and observance of the Obligations.
- 2. <u>Excluded Assets</u>. The Grantors and Agent do hereby agree that the "Trademark Collateral" will exclude any United States intent-to-use trademark applications prior to the filing of a "Statement of Use" or "Amendment to Allege Use" with respect thereto, to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration issuing from such intent-to-use trademark application under applicable federal law.

The Grantors do hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

THIS SUPPLEMETAL TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
