TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of November 2, 2015 (this "**Termination and Release**"), by Credit Suisse AG, as collateral agent (in such capacity, the "**Agent**"), in favor of Jostens, Inc., a Minnesota corporation, The Lehigh Press LLC, a Delaware limited liability company, Neff Motivation, Inc., an Ohio corporation, Memory Book Acquisition LLC, a Delaware limited liability company, and Rock Creek Athletics, Inc., an Iowa corporation (collectively, the "**Grantors**"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of September 23, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Visant Corporation, a Delaware corporation (the "**Borrower**"), Visant Secondary Holdings Corp., a Delaware corporation ("**Holdings**"), the Lenders from time to time party thereto and Credit Suisse AG, as the Administrative Agent and the Collateral Agent, (ii) the Security Agreement dated as of September 23, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), among the Borrower, Holdings, the subsidiaries of the Borrower from time to time party thereto and Credit Suisse AG, as Collateral Agent, and (iii) the Grant of Security Interest in Trademark Rights dated as of September 23, 2014 (the "**Trademark Security Agreement**"), made by the Grantors and Phoenix Color Corp., a Delaware corporation, in favor of the Agent (such documents set forth in clauses (ii) through (iii), the "**Security Agreements**").

B. Pursuant to the Security Agreements, the Grantors granted to the Agent, for the benefit of the Secured Parties, a security interest in the trademarks of the Grantors set forth on Schedule I hereto, including the goodwill associated with such trademarks and the right to receive all Proceeds therefrom (the "**Trademarks**"), which security interest was recorded with the United States Patent & Trademark Office on September 26, 2014 at Reel/Frame 5369/0773.

C. The Borrower has informed the Agent that, in connection with the Payoff Letter dated as of November 2, 2015 between the Borrower and the Agent, the Borrower requests the release of all right, title and interest of the Agent and the Secured Parties in, to and under the Trademarks granted under the Security Agreements.

Accordingly, for good and valuable consideration, including the satisfaction of the Obligations secured by the Trademarks, the receipt and sufficiency of which are hereby acknowledged, all of the Agent's right, title and interest (including, without limitation, security interests and liens) in, to and under the Trademarks shall hereby automatically terminate as provided in the Security Agreements, and the Agent hereby terminates, cancels, releases and discharges its security interests and liens in, to

and under the Trademarks and hereby re-transfers, re-conveys and re-assigns all of the Agent's right, title and interest in, to and under the Trademarks to the applicable Grantor.

The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.




