RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Security Agent for the benefit of the Secured Parties a security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as defined below); and

WHEREAS, the Security Agent desires to terminate and release the security interest in the Trademark Collateral.




The term "Trademark Collateral," as used herein, shall mean (i) all trademark and service mark registrations and applications as set forth in the Schedule of Trademarks to the Trademark Security Agreement (the "Schedule of Trademarks"), (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights or any kind whatsoever of the Grantor accruing thereunder or pertaining thereto, (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and (iv) all proceeds of income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the foregoing.

The Security Agent hereby terminates, discharges and releases the security interest in the trademark and service mark registrations and applications set forth in the Schedule of Trademarks, without representation, warranty, or recourse.
