## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of November 12, 2015 (the "Effective Date"), is made by The Bank of New York Mellon Trust Company, N.A. in its capacity as trustee (the "Collateral Agent"), in favor of PolyOne Corporation, NEU Specialty Engineered Materials, LLC, Polymer Diagnostics, Inc., ColorMatrix Holdings, Inc., The ColorMatrix Corporation, Gayson Silicone Dispersions, Inc., PolyOne Designed Structures and Solutions LLC (successor to Spartech Research and Development, LLC, Spartech Polycom, Inc., Spartech Polycast, Inc., Spartech International – U.S. Distribution Co., Alchem Plastics Corporation, Spartech Polycom (Texas), Inc., Spartech Townsend, Inc., Spartech FCD, LLC, Creative Forming, LLC and Polymer Extruded Products, LLC), Franklin-Burlington Plastics, Inc. and Glasforms, Inc. (collectively, the "Grantors").

WHEREAS, pursuant to that certain Security Agreement, dated as of December 21, 2011, by and among the Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement, dated as of December 21, 2011, a Trademark Security Agreement, dated as of February 1, 2013 and a Trademark Security Agreement, dated as of March 21, 2013 (the "Trademark Security Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on December 29, 2011 at Reel/Frame 4688/0301, on December 29, 2011 at Reel/Frame 4688/0776, on December 29, 2011 at Reel/Frame 4688/0759, on December 29, 2011 at Reel/Frame 4688/0713, on December 29, 2011 at Reel/Frame 4688/0727, on December 29, 2011 at Reel/Frame 4688/0745, on April 18, 2013 at Reel/Frame 5009/0258, on April 18, 2013 at Reel/Frame 5009/0447, on April 18, 2013 at Reel/Frame 5009/0510, on April 18, 2013 at Reel/Frame 5009/0439; on April 18, 2013 at Reel/Frame 5009/0475; on April 18, 2013 at Reel/Frame 5009/0463 and on April 18, 2013 at Reel/Frame 5009/0455;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth in Schedule A attached hereto, arising under the Security Agreement and Trademark Security Agreements. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.


