- 1. <u>Assignment.</u> Assignor hereby contributes, conveys, transfers, assigns and delivers to Assignee all of Assignor's right, title and interest throughout the world in and to (a) the Company Marks (and the registrations and applications therefor) listed on <u>Attachment 1</u> attached hereto and all goodwill corresponding thereto (collectively, the "Assigned Trademarks") and (b) (i) all rights pertaining to the Assigned Trademarks arising under international treaties and convention rights; (ii) the right and power to assert, defend and recover title to the Assigned Trademarks; (iii) all rights to assert, defend, sue, and recover damages for any past, present and future infringement, misuse, misappropriation, impairment, unauthorized use or other violation of any rights in or to the Assigned Trademarks; (iv) all proceeds, income, royalties, damages and payments now and/or hereafter due and payable under and/or in respect of the Assigned Trademarks; and (v) all administrative rights arising from the Assigned Trademarks, including the right to prosecute applications and oppose, interfere with or challenge the applications of others, the rights to obtain renewals, continuations, divisions, and extensions of legal protection pertaining to the Assigned Trademarks.
- 2. <u>Terms of the Purchase Agreement.</u> This Trademark Assignment is subject in all respects to the terms and provisions of the Purchase Agreement, including, but not limited to, Assignor's representations, warranties and covenants relating to the Assigned Trademarks.
