PURPOSE

MINDRAY SWEDEN is now the sole owner of all rights, title and interest in the TRADEMARKS and future ADDITIONAL APPLICATIONS. MR Holdings wants to acquire all rights, title and interest in and to the TRADEMARKS and future ADDITIONAL APPLICATIONS.

CONSIDERATION

MINDRAY SWEDEN and MR Holdings agree to enter into the Assignment for a price of 2,060,000 U.S. dollars, inclusive of all taxes and outlays. MINDRAY SWEDEN acknowledges that it has received valuable consideration for this Assignment.


NOW THEREFORE:

1. MINDRAY SWEDEN assigns and transfers to MR Holdings, its successors, assigns and legal representatives, the entire right, title and interest in and to the TRADEMARKS and any future ADDITIONAL APPLICATIONS;
2. MINDRAY SWEDEN agrees that the rights it conveys to MR Holdings include all priority rights arising from the filing of the TRADEMARK APPLICATIONS, the right to own in MR Holdings's own name the TRADEMARKS, and the sole and exclusive right to file any future ADDITIONAL APPLICATIONS;
3. MINDRAY SWEDEN agrees to execute all documents requested by MR Holdings and its successors, assigns and legal representatives regarding the filing and prosecution of all applications for TRADEMARKS and any future ADDITIONAL APPLICATIONS. If MINDRAY SWEDEN is prevented from signing such documents, this ASSIGNMENT shall be valid as a Power of Attorney for MR Holdings to sign these documents on MINDRAY SWEDEN's behalf.
4. Upon the request of MR Holdings and its successors, assigns and legal representatives, and at MR Holdings's expense, regarding the filing and prosecution of all applications for TRADEMARKS and any future ADDITIONAL APPLICATIONS, MINDRAY SWEDEN agrees to provide to MR Holdings and its successors, assigns and legal

representatives all information known to or ascertainable by MINDRAY SWEDEN and all documents and other materials and objects pertaining to MR Holdings's rights in the TRADEMARKS that are in MINDRAY SWEDEN's possession or accessible to MINDRAY SWEDEN; and further, at any trial, hearing, deposition or other legal proceeding where any employee or representative of MINDRAY SWEDEN is called as a witness by MR Holdings or its successors, assigns and legal representatives, MINDRAY SWEDEN agrees to make such employee or representative available to testify, either by deposition or at trial, to all facts pertaining to MR Holdings's rights in the TRADEMARK for which the employee or representative is competent to testify;

5. MINDRAY SWEDEN warrants and represents that the TRADEMARKS are its property; that MINDRAY SWEDEN has conveyed no assignment, grant, lien, mortgage, license or other encumbrance affecting the TRADEMARKS to any other physical or legal person, that, to its knowledge, no such conveyance exists otherwise; and that MINDRAY SWEDEN has the full power to convey the rights assigned in this ASSIGNMENT.
