**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June 24, 2015 (the "Effective Date"), is made by Bank of America, N.A., in its capacity as Administrative Agent for the Secured Parties (the "Agent"), in favor of the grantor parties identified on the signature page hereto (the "Grantors").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of September 25, 2007, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain Intellectual Property Collateral;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered Trademark Security Agreements, dated as of (i) September 25, 2007, (ii) November 11, 2009 (the "2009 Trademark Security Agreement") and (iii) January 13, 2014 (collectively, the "Trademark Security Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements (except for the 2009 Trademark Security Agreement) were recorded with the United States Patent and Trademark Office on (i) December 10, 2007 at Reel/Frame 003674/0700, and (ii) January 17, 2014 at Reel/Frame 5196/0378;

WHEREAS, the 2009 Trademark Security Agreement was intended to be recorded with the United States Patent and Trademark Office, but was not recorded with respect to the applicable Trademark Collateral (as defined in the 2009 Trademark Security Agreement) under the 2009 Trademark Security Agreement, and documents unrelated to the 2009 Trademark Security Agreement were instead recorded on November 12, 2009 at Reel/Frame 004095/0124 (the "Incorrect Recordation"); and

WHEREAS, the indebtedness described in and the obligations under the Security Agreement and all security interests in the Intellectual Property Collateral, including the Trademark Collateral, are fully discharged and released and the Security Agreement and the Trademark Security Agreement are canceled and terminated.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, except as otherwise provided in this Release or the Security Agreement, hereby releases, discharges, terminates and cancels all of its security interest in all right, title and interest in, to or under the Trademark Collateral, including the trademark registrations and applications set forth on Schedule A attached hereto, arising under the Security Agreement and the Trademark Security Agreements, including, for the avoidance of doubt and notwithstanding the Incorrect Recordation, under the 2009 Trademark Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement or the Trademark Security Agreements, the Agent, without representation or warranty of any kind, except as otherwise provided in this Release or the Security Agreement, hereby re-

transfers, re-conveys and re-assigns such right, title or interest to the Grantors. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademark Collateral.

3. Termination. The Agent hereby terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns, transferees or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.


5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.

6. This Release shall be binding upon the Agent's successors, assigns, transferees and other legal representatives, and is made in favor of and for the benefit of Grantors and their respective successors and assigns.
