TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

December 1, 2015

WHEREAS, Silver Star Brands, Inc., a Wisconsin corporation ("Silver Star"), PartyLite Gifts, Inc., a Virginia corporation ("PartyLite Gifts"), PartyLite Worldwide, LLC, a Delaware limited liability company ("PartyLite WW"), Candle Corporation of America, a New York corporation ("Candle Corp" and together with, Silver Star, PartyLite Gifts and PartyLite WW, collectively, the "Grantors" and each a "Grantor"), have entered into a certain Trademark Collateral Assignment and Security Agreement dated March 9, 2015 (the "Trademark Security Agreement") with GFIE, LLC, a Florida limited liability company (the "Original Lender"), notice of which was recorded on March 9, 2015 at the United States Patent and Trademark Office ("USPTO") at Reel 5474, Frame 0033.

WHEREAS, Grantors granted the Original Lender, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Original Lender, in and to certain of Grantors' trademarks and service marks (the "Marks") identified in Schedule A and all of the goodwill of the business symbolized by and associated with the Marks and the registrations thereof, as well as the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks or the registrations thereof or such associated goodwill.

WHEREAS, pursuant to that certain Assignment of Trademark Security Agreement by and between the Original Lender and **Crosby Rock LLC** ("**Successor Lender**"), a Delaware limited liability company, the Original Lender has assigned and transferred to Successor Lender all of its rights, title and interest in and to the Trademark Security Agreement.

WHEREAS, the Successor Lender has agreed to terminate and release its security interest in all such Marks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Successor Lender, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates, cancels and discharges any and all of its interest in the Marks, and all of the goodwill of the business symbolized by and associated with the Marks and the registrations thereof, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest and any other liens. Grantor (or its designee) is hereby authorized to file this Termination and Release of Security Interest in Trademarks (the "Release") with the USPTO and any other governmental authority.

The delivery of an executed counterpart of a signature page to this Release by email or facsimile shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the laws of the State of New York (without giving effect to its principles of conflicts of law) and shall relate solely to the Trademark Security Agreement.
