Assignor agrees to execute any further papers as may be necessary and proper to vest full title in and to the Mark and other corresponding rights in the Assignee, its successors, assigns and legal representatives. Assignor hereby consents to the recordation of this assignment in the territories listed in Schedule "A" and any other territories as appropriate. The individuals signing this document on behalf of corporate entities represent and declare that they are authorized to execute this document on behalf of such corporate entities.

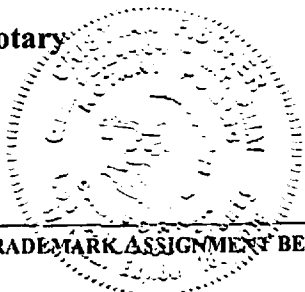

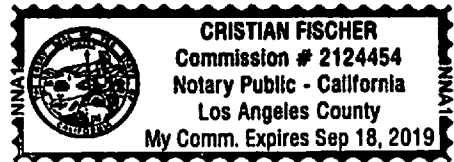
