## ASSIGNMENT OF TRADEMARKS, TRADE NAMES, AND SERVICE MARKS

THIS ASSIGNMENT OF TRADEMARKS, TRADE NAMES, AND SERVICE MARKS ("Assignment") is made effective as of November 30, 2015, by CORONET JEWELRY COMPANY, an Ohio corporation ("Assignor") in favor of CORONET JEWELRY and ACCESSORIES, LLC, an Ohio limited liability company ("Assignee"), is to evidence the following agreements and understandings:

### RECITALS

A. Assignor is the sole owner of those trademarks, trade names, and service marks listed on Schedule A, attached and made a part hereto, and other derivatives thereof, as such may be registered with the Ohio Secretary of States, the United States Patent and Trademark Office, or may be unregistered or common law trade names, trademarks, or service marks (collectively, the "Marks").

B. Pursuant to an Asset Purchase Agreement dated November 30, 2015, (the "Purchase Agreement") by and among Assignor, as seller, Assignee, as purchaser, Matthew Winograd, and Lee Schloss and Mark Schloss, (the "Purchase Agreement"), Assignee is purchasing certain assets of Assignor, including the Marks and all goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby sells, assigns, transfers and sets over unto Assignee the exclusive right, title and interest in and to the Marks and the use thereof throughout the world, together with the goodwill pertaining to said Marks. The Marks are assigned by Assignor "as is" and without any warranties whatsoever.

Assignor makes no claims as to Assignor's right, title, or ownership of the Marks, nor to Assignor's knowledge of any existing infringement of the Marks by any third party.

Assignor covenants and agrees to execute and deliver to Assignee, upon request, all such further documents, instruments and other writings which Assignee reasonably requests to effectuate the assignments set forth herein and/or to effectuate a registration of the Marks as a trade name, trademark, service mark, or otherwise with any governmental entity.

This Assignment shall be governed by and construed in accordance with the substantive laws of the State of Ohio, without application of choice or conflict of laws principals.


