## EXECUTION

### TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “**Assignment**”) is made and entered into as of March 4, 2015 by Hem Design Inc., a Delaware corporation (“**Assignor**”), in favor of Agora Retail Limited, an Ireland company (“**Assignee**”). Capitalized terms used but not defined herein shall have the meanings ascribed thereto in the Asset Purchase Agreement or the Intellectual Property Assignment and Assumption Agreement (each defined below).

WHEREAS, Assignor has agreed to transfer, or cause to be transferred, the Purchased Assets to the Buyer Entities, including Assignee, upon the terms and subject to the conditions of that certain Master Asset Purchase Agreement dated as of March 2, 2015 among Assignor, PCH International Holdings and the other parties thereto (the “**Asset Purchase Agreement**”);

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor and Assignee entered into that certain Intellectual Property Assignment and Assumption Agreement dated as of March 4, 2015 (the “**Intellectual Property Assignment and Assumption Agreement**”) to effect certain transfers required under the Asset Purchase Agreement; and

WHEREAS, the Intellectual Property Assignment and Assumption Agreement requires the execution and delivery of this Assignment by the parties hereto.

NOW, THEREFORE, in consideration of the promises and the mutual representations, warranties, covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby assigns, conveys and transfers to Assignee all of its right, title and interest in and to:

(a) the registered trademarks and trademark applications listed on Schedule 1 attached hereto (the “**Assigned Trademarks**”);

(b) the goodwill of the business associated with or otherwise symbolized by the Assigned Trademarks; and

(c) the right to sue and recover for, and the right to the profits or damages due or accrued arising out of or in connection with any and all past, present or future infringements, misappropriations or other violations of, or passing off or dilution of or damage or injury to, the Assigned Trademarks.

2. As further set forth in the Asset Purchase Agreement, Assignor shall, at Assignee's reasonable request, take such further action and execute such additional agreements and instruments as may be necessary to effect and perfect the assignment contemplated hereby.

3. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to its conflicts of law principles.

4. This Assignment may be executed in counterparts, by either an original signature or signature transmitted by facsimile transmission, PDF, or other similar process, and each copy so executed shall be deemed to be an original and all copies so executed shall constitute one and the same agreement.
