INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated as of January 13, 2016 ("IP Assignment Effective Date"), is made by and between **Colt's Manufacturing IP Holding Company LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 545 New Park Avenue, West Hartford, Connecticut 06110, U.S.A ("US IP Holdco") and the following entities (individually an "Assignor" and collectively, "Assignors"):

1. **Colt's Manufacturing Company LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 545 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
2. **Colt Defense LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
3. **Colt Defense Technical Services LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
4. **New Colt Holding Corp.**, a corporation organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 545 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
5. **Colt Finance Corp.**, a corporation organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
6. **Colt International Coöperatief U.A.**, a corporation organized and existing under the laws of The Netherlands, with offices and a principal place of business located at Prins Bernhardplein 200, 1097 JB Amsterdam, The Netherlands;
7. **Colt Holding Company LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.;
8. **Colt Security LLC**, a limited liability company organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.; and
9. **CDH II Holdco Inc.**, a corporation organized and existing under the laws of the State of Delaware, United States of America, with offices and a place of business located at 547 New Park Avenue, West Hartford, Connecticut 06110, U.S.A.

1. Assignment of Intellectual Property. In consideration of the sum of ten dollars (\$10.00), and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to applicable export control laws, rules and regulations, each Assignor agrees to convey, transfer and assign, and hereby conveys, transfers and assigns to US IP Holdco, and US IP Holdco hereby accepts, all of each such Assignor's domestic and foreign right, title and interest, as of the IP Assignment Effective Date and thereafter, in and to all (i) inventions, discoveries and ideas, whether patentable or not, and all patents, registrations and applications thereto, including without limitation divisions, continuations, continuations-in-part, reexaminations, reissues, extensions and renewal applications; (ii) published and unpublished works of authorship, whether copyrightable or not, copyrights therein and thereto and registrations and applications thereto, and all renewals, extensions, restorations and reversions thereof; (iii) subject to Section 2 of this IP Assignment, trademarks, service marks, trade names, trade dress, brand names, Internet domain names, logos, symbols, and other indicia of origin, all applications and registrations for all of the foregoing, and all goodwill associated therewith and symbolized thereby, including without limitation all extensions, modifications and renewal of the same; (iv) confidential and proprietary information, trade secrets and know-how, including, without limitation, technical data packages, formulae, processes, compounds, drawings, designs, industrial designs, blueprints, surveys, reports, manuals, operating standards and customer lists; (v) software and contract rights relating to computer software programs, in whatever form created or maintained; and (vi) all other intellectual property rights or proprietary rights and claims or causes of action arising out of or related to any infringement, misappropriation or other violation of any of the foregoing throughout the world, including, without limitation, rights to recover for past, present and future violations thereof and any and all products and proceeds of the foregoing (collectively "Intellectual Property"). Specifically included in the Intellectual Property assigned by Assignors to US IP Holdco are (i) all of the issued patents and patent applications listed in the attached **Exhibit A**; (ii) all of the registered trademarks and service marks and pending trademark and service mark applications listed in the attached **Exhibit B**; (iii) all of the registered copyrights and copyright applications listed in the attached **Exhibit C**.

2. Intent to Use Trademark Applications. To the extent an Assignor's Intellectual Property includes a trademark for which such Assignor has filed an Intent-To-Use ("ITU") application with the United States Patent and Trademark Office under 15 U.S.C. §1051(b)(1) as of the IP Assignment Effective Date or thereafter, said ITU application shall remain in Assignor's name until such time that Assignor's amendment to allege use or verified statement of use pursuant to 15 U.S.C. § 1060(a) (or any successor provision) has been submitted to and accepted by the United States Patent and Trademark Office, upon which event, such Assignor agrees to convey, transfer and assign, and hereby conveys, transfers and assigns to US IP Holdco, and US IP Holdco hereby accepts, all of such Assignor's right, title and interest in and to such trademark and all applications and registrations for such trademark, and all goodwill associated therewith and symbolized thereby, including without limitation all extensions, modifications and renewal of the same. The trademarks for which an Assignor has filed an ITU application with the United States Patent and Trademark Office as of the IP Assignment Effective Date are listed in the attached **Exhibit D**.

3. Moral Rights. Each Assignor hereby authorizes US IP Holdco to utilize any and all moral rights in the Intellectual Property that have been waived in favor of such Assignor, and agrees that such Assignor will not make any use of the moral rights waived in its favor without prior written consent of US IP Holdco on or after the IP Assignment Effective Date.

4. Internet Domain Names & Webpages. Each Assignor shall provide US IP Holdco with all passwords, login details and identifications, as well as all other information required for US IP Holdco to register the assignment of all Internet domain names to US IP Holdco with the associated domain name registrar(s), and to receive rights of access, administration and all other uses of the Internet domain names for the remaining portion of the term of rights granted by the registrar in the Internet domain names, and to renew the Internet domain names. Each Assignor shall provide US IP Holdco with all passwords, login details and identifications, and all software code in all formats as required to access, maintain, modify, update, upgrade, administer and otherwise utilize and provide use to others of all webpages assigned to US IP Holdco.

5. Recordation and Further Actions. Upon US IP Holdco's reasonable request, subject to applicable export control laws, rules and regulations, each Assignor will take such steps and actions, and provide such cooperation and assistance to US IP Holdco, and its legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Intellectual Property to US IP Holdco.
