In consideration of the sum of One Dollar (\$1.00), and of other good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign to the maximum extent permitted by applicable law unto the said Assignee, which accepts, any and all interests to the worldwide copyright in and to the artworks, graphics, logos relating to the marks "THE ATHLETE'S FOOT", the Old, New and 3-Winged Foot Designs" and "TAF", as well as to their trade dress.

3. In consideration of the sum of One Dollar (\$1.00), and of other good and valuable consideration, receipt of which is hereby acknowledged, Assignor agrees to effectuate the transfer of the Domain Names to Assignee, and Assignee agrees to accept the transfer and take whatever additional steps are required in order to effectuate the transfer.

4. Finally, Assignor does hereby assign unto the said Assignee, which accepts, the rights to a system of methods, operating procedures, special designs, operating policies, marketing concepts, management techniques, communications methods and procedures and advertising techniques for the operation of stores offering the sale of athletic shoes, private label goods and related products under the names THE ATHLETE'S FOOT and TAF.

The Assignor further agrees that at the request of the Assignee it will at all times hereafter do all such acts and execute all such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder and to assist in the resolution of any question concerning the trademarks and generally the content of the instant Assignment Deed.


