Pursuant to Title 8, Section 264(c) of the General Corporation Law of the State of Delaware and Title 6, Section 18-209 of the Limited Liability Company Act of the State of Delaware

Tokka LLC, a Delaware limited liability company ("**Company**"), does hereby certify as follows:

**FIRST:** The name of the surviving Delaware limited liability company is Tokka LLC and the name of the Delaware corporation being merged with and into this surviving limited liability company is bebop Technologies, Inc. ("**bebop**").

**SECOND:** An Agreement and Plan of Merger dated November 18, 2015, as amended on December 14, 2015 (the "**Merger Agreement**"), by and among Google Inc., a Delaware corporation, Hamato Inc., a Delaware corporation, Company, bebop and certain other parties set forth therein, setting forth the terms and conditions of the merger of bebop with and into Company (the "**Merger**"), with Company remaining as the surviving limited liability company of the Merger, has been approved, adopted, certified, executed and acknowledged by each of Company and bebop in accordance with Title 8, Section 264(c) of the General Corporation Law of the State of Delaware, including by the stockholders of bebop by written consent in accordance with Title 8, Section 228 of the General Corporation Law of the State of Delaware, and in accordance with Title 6, Section 18-209 of the Limited Liability Company Act of the State of Delaware.

**THIRD:** The name of the surviving limited liability company (the "**Surviving Company**") shall be Tokka LLC.

**FOURTH:** The Certificate of Formation of Company, as in effect immediately prior to the Merger, shall be the Certificate of Formation of the Surviving Company.
