CERTIFICATE OF CONVERSION
FROM A DOMESTIC OKLAHOMA CORPORATION TO A
FOREIGN LIMITED LIABILITY COMPANY PURSUANT TO
SECTION 18-1090.5 OF THE OKLAHOMA GENERAL CORPORATION ACT

- 1.) The name of the Oklahoma corporation is presently "Anchor Drilling Fluids USA, Inc." It was originally incorporated under the name "Jordan Drilling Fluids, Inc."
- 2.) The date the original certificate of incorporation was filed with the Oklahoma Secretary of State was May 14, 1984.
- 3.) The Oklahoma corporation will be converted into a Delaware limited liability company. It will operate under the name "Anchor Drilling Fluids USA, LLC."
- 4.) The conversion has been approved in accordance with the provisions of Oklahoma law. On December 22, 2015, the Board of Directors unanimously approved the conversion and recommended approval to the sole shareholder. By written consent dated December 22, 2015, the sole shareholder approved the conversion.
- 5.) The conversion is to become effective upon filing Certificates of Conversion with the states of Delaware and Oklahoma on December 31, 2015, and filing a Certificate of Formation with the state of Delaware on December 31, 2015.
- 6.) The authorized officer executing this Certificate of Conversion shall continue as an officer of the converted limited liability company pursuant to the terms of a plan of entity conversion and, accordingly, the authorized officer states on behalf of Anchor Drilling Fluids USA, LLC that it may be served with process in Oklahoma in any action, suit or proceeding for enforcement of any obligation of Anchor Drilling Fluids USA, LLC arising while it was an Oklahoma corporation and that Anchor Drilling Fluids USA, LLC hereby irrevocably appoint the Secretary of State of the state of Oklahoma as its agent to accept service of process in any such action, suit or proceeding. 
