## ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to the Adhesive Brand Assets Transfer Agreement dated December 15, 2015 ("Adhesives Transfer Agreement"), the Trademarks were acquired by Assignee; and

WHEREAS, the parties hereto desire to confirm the transfer of the Trademarks from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged:


1. Assignment. Assignor confirms that it assigned and transferred to Assignee, and Assignee confirms that it agreed to purchase and acquire from the Assignor, as of December 31, 2015, all of the Assignor's right, title and interest in and to the Trademarks, together with any goodwill symbolized by the Trademarks, including without limitation, the right to any registration thereof, the right to prosecute any application therefore, the right to have any registrations issue in the name of the Assignee, the right to apply for and obtain any renewal of any registrations thereof, the right to sue for past and future infringement and the right to the goodwill of the business symbolized thereby.
2. Further Assurances. Assignor will execute any and all additional documents that may be reasonably necessary for Assignee to perfect the transfer of rights set forth herein.
3. Binding Provisions. This Agreement is binding upon, and inures to the benefit of, the parties hereto and their respective heirs, executors, legal representatives, successors, and permitted assigns.
4. Governing Law. All questions concerning the construction, validity and interpretation of this Agreement and the performance of the obligations imposed therein shall be governed by the laws of Germany.




