**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 26, 2016 (“Release”), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as collateral agent (in such capacities, the “Collateral Agent”) for the benefit of the Secured Parties that are parties to the Credit Agreement described below and **BANK OF AMERICA, N.A.**, as co-collateral agent and administrative agent (the “Administrative Agent”), in favor of **PETCO ANIMAL SUPPLIES, INC.** a Delaware corporation (the “Borrower”) and the subsidiaries of the Borrower party to the Trademark Security Agreements (as defined below) (together with the Borrower, the “Grantors”). Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Credit Agreement, Pledge and Security Agreement or Trademark Security Agreements.

WHEREAS, pursuant to (a) the ABL Credit Agreement dated as of April 19, 2013 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), among the Borrower, the subsidiaries from time to time party thereto (the “Subsidiaries”), the lenders from time to time party thereto, the Collateral Agent and the Administrative Agent, as successor in interest to Credit Suisse AG, to which Petco Wellness, LLC, a Delaware limited liability company (“Petco Wellness”) joined by way of that certain Joinder Agreement dated as of November 7, 2014 by and among Petco Wellness, the Administrative Agent and the Collateral Agent and (b) the Pledge and Security Agreement dated as of April 19, 2013 (as amended, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”), among the Borrower, the Subsidiaries, the Collateral Agent and the Administrative Agent, to which Petco Wellness joined by way of Supplement No. 2 to the Pledge and Security Agreement, dated as of November 7, 2014, the Grantors executed and delivered the Trademark Security Agreement dated as of April 19, 2013, as recorded at the United States Patent and Trademark Office (“USPTO”) on April 25, 2013 at Reel 5014 Frame 222 and the Trademark Security Agreement dated as of November 13, 2015, as recorded at the USPTO on November 25, 2015 at Reel 5676 Frame 0634 (each a “Trademark Security Agreement”, and collectively the “Trademark Security Agreements”), and the lenders made extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, pursuant to the Pledge and Security Agreement and Trademark Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right title and interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time thereafter may have acquired any right, title or interest: (a) all common law trademarks, trademark registrations and trademark applications, common law service marks, service mark registrations and service mark applications, trade names, corporate names, trade dress and logos, including those set forth on Schedule A hereto, and the goodwill of the business symbolized by the foregoing; (b) all extensions and renewals of the foregoing; (c) all income, royalties, damages and payments then or thereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past and future infringements thereof; (d) all rights to sue for past, present and future infringements of the foregoing; and (e) all rights corresponding to any of the foregoing throughout the world (the “Trademark Collateral”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Collateral Agent hereby absolutely and unconditionally cancels, discharges, and releases the security interest in and to the Trademark Collateral granted pursuant to the Trademark Security Agreements, and hereby reassigns to Grantors any right, title or interest they may have in the Trademark Collateral granted pursuant to the Trademark Security Agreements. The Collateral Agent authorizes the recordation of this Release with the USPTO.
