RELEASE OF TRADEMARK SECURITY AGREEMENT
(Senior Debt)

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of January 29, 2016, is made by FIFTH THIRD BANK, an Ohio banking corporation ("Lender"), through its Structured Finance Group ("Secured Party").

WHEREAS, Secured Party and PANOS BRANDS, LLC, a Delaware limited liability company, are parties to that certain Trademark Security Agreement, dated as of December 17, 2010, which was recorded with The United States Patent and Trademark Office on December 23, 2010 at Reel 004440, Frame 0587, as amended by that certain First Amendment to Trademark Security Agreement dated as of February 25, 2013, which was recorded with The United States Patent and Trademark Office on March 1, 2013 at Reel 4973, Frame 0779, and that certain Second Amendment to Trademark Security Agreement dated as of April 2, 2014, which was recorded with The United States Patent and Trademark Office on April 4, 2014 at Reel 5251, Frame 0818 (as amended, the "Agreement");

WHEREAS, the Agreement granted to Secured Party a continuing security interest in and to, and Lien on, (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications (exclusive, for purposes only of this Agreement, of any Intent to Use Applications), including each U.S. federally registered mark, registration, and application listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being, collectively, the "Trademarks"); (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks; (d) all rights to sue for past, present and future infringements of any and all Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark applications, including the licenses listed on Schedule I and the Trademark Licenses; and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademarks solely as granted under the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest in, Liens on, and all other rights in, to and under the Trademarks granted under the Agreement.
