## TERMINATION OF REVOLVER PLEDGE AND SECURITY AGREEMENT

This TERMINATION OF REVOLVER PLEDGE AND SECURITY AGREEMENT, dated as of February 8, 2016, is made by Silver Point Finance, LLC and SummitBridge National Investments LLC (collectively, the "Secured Parties").

**WHEREAS**, SourceLink Acquisition, LLC, SourceLink Carolina, LLC and SourceLink Madison, LLC (collectively, the "Grantor") granted to the Secured Parties a security interest in certain trademarks listed on Exhibit A hereto (the "Trademarks"), pursuant to that certain Revolver Pledge and Security Agreement dated September 30, 2005, by and between the Grantor and the Secured Parties (the "Security Agreement");
