RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of December 8, 2015, is made by Deutsche Bank Trust Company Americas (f/k/a Bankers Trust Company), in its capacity as collateral agent (the "Assignee"), in favor of Corporate Express, Inc., a Colorado corporation which has or had an office at One Environmental Way, Broomfield, CO (the "Assignor").

WITNESSETH:

WHEREAS, pursuant to that certain Assignment of Security Interest in United States Trademarks and Patents, dated as of October 26, 1999 (the "Trademark Security Agreement"), the Assignor granted to the Assignee a security interest in the trademarks listed on Exhibit A attached hereto, together with any applications for federal registration or federal registrations therefor (collectively, the "Released Trademarks");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby releases and terminates its liens and security interests in the Released Trademarks, all renewals or extensions of the foregoing, the goodwill of the businesses with which the Released Trademarks are associated, and all products and proceeds of the foregoing, including, without limitation, all causes of action for infringement of any of the Released Trademarks or unfair competition regarding the same.


