**RELEASE OF SECURITY INTEREST IN UNITED STATES
TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Release"), dated as of December 8, 2015, is made by Deutsche Bank AG, acting through its London Branch, in its capacity as Security Agent (the "Grantee"), in favor of Corporate Express US Inc., a Colorado corporation which has or had an office at One Environmental Way, Broomfield, CO (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks, dated as of April 7, 2008 (the "Trademark Security Agreement"), the Grantor granted to the Grantee a security interest in the trademarks listed on Exhibit A attached hereto, together with any applications for federal registration or federal registrations therefor (collectively, the "Released Trademarks");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases and terminates its liens and security interests in the Released Trademarks, all renewals or extensions of the foregoing, the goodwill of the businesses with which the Released Trademarks are associated, and all products and proceeds of the foregoing, including, without limitation, all causes of action for infringement of any of the Released Trademarks or unfair competition regarding the same.
