## TRADEMARK AND SERVICE MARK ASSIGNMENT

THIS TRADEMARK AND SERVICE MARK ASSIGNMENT ("Assignment") is made and entered into as of January 3, 2016 by Wolverine World Wide, Inc., a Delaware corporation ("Assignor"), and Wolverine Outdoors, Inc., a Michigan corporation ("Assignee").

WHEREAS, Assignor owns certain trademarks, service marks and copyrights (collectively, the "Marks"), including, but not limited to, those listed on Exhibit A, as well as the registrations for the Marks and pending applications for registration of the Marks, including, but not limited to, those listed on Exhibit A;

WHEREAS, Assignee desires to acquire, and Assignor desires to assign and transfer to Assignee, the entire right, title and interest in and to the Marks and the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee the entire right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks. The parties agree that the assignment contemplated hereby includes: (1) the registrations for the Marks and pending applications for registration of the Marks; (2) all rights of any kind whatsoever of Assignor accruing under the Marks provided by the applicable laws of any jurisdiction, by international treaties and conventions and otherwise throughout the world, including all rights to apply for, obtain and maintain all registrations, renewals and extensions thereof; (3) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any of the Marks; and (4) any and all claims and causes of action with respect to any of the Marks, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default related to the Marks, with the right to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Assignor hereby authorizes the officials of all trademark offices in the jurisdictions applicable to the Marks to record Assignee as the owner of the Marks, and to issue any and all registrations, renewals, extensions and otherwise for the Marks to Assignee, as assignee of Assignor's entire right, title and interest in and to the same, and to record and register this Assignment upon request by Assignee. Assignor agrees that it shall deliver any further instruments or documents, and take all such further action, as Assignee may request, including procuring assurance and cooperation from Assignor's officers and employees, in order to transfer to and vest in Assignee all right, title and interest in and to the Marks. Assignor hereby appoints Assignee as its power-of-attorney, effective as of the date hereof, with full right of substitution, for the purpose of executing such documents and taking such other actions. This power-of-attorney shall be for the benefit of Assignee and its successors and assigns, is irrevocable, and is coupled with an interest.

The terms and provisions of this Assignment shall be deemed severable, and the invalidity or unenforceability of any term or provision shall not affect the validity or enforceability of the other terms and provisions hereof. If any term or other provision of this

Assignment, or the application thereof to any person or any circumstance, is invalid, illegal or unenforceable, (1) a suitable and equitable term or provision shall be substituted therefor in order to carry out, so far as may be valid and enforceable, the intent and purpose of such invalid or unenforceable term or provision, and (2) the remainder of this Assignment and the application of such term or provision to other persons or circumstances shall not be affected by such invalidity, illegality or unenforceability, nor shall such invalidity, illegality or unenforceability affect the validity or enforceability of such term or provision, or the application thereof, in any other jurisdiction.


