RELEASE OF SECURITY INTEREST IN TRADEMARKS

- 2. <u>Release</u>. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademark registrations and applications set forth <u>Schedule A</u> attached hereto (the "<u>Trademark Collateral</u>"), arising under the Security Agreement and the Trademark Security Agreements, and hereby assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Trademark Collateral that the Agent may hold.
- 3. <u>Termination</u>. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
- 4. <u>Further Assurances</u>. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
