**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE**, effective as of March 9, 2016, by and between WELLS FARGO TRADE CAPITAL SERVICES, INC., having an address at 100 Park Avenue, New York, New York 10016 (hereinafter referred to as "Releasor") and USPA Accessories LLC, a limited liability company organized under the laws of the State of New York and having an address at 119 West 40th Street, 3rd Floor, New York, New York 10018 (hereinafter referred to as "Company").

**NOW, THEREFORE**, Releasor does hereby forever release, discharge and terminate its security interest solely in the Released Marks and re-assign and grant back to the Company the goodwill of the business symbolized by the Released Marks, without recourse or representation or warranty, express or implied, of any kind.

Except for the Released Marks, Releasor retains its lien on and security interest in all other trademarks assigned to Releasor for security under the Original Assignment.

For the avoidance of doubt, it is acknowledged and agreed that, except for the Released Trademarks released hereunder, this Partial Release does not release, relinquish or discharge Releasor's security interest in any other trademarks (including but not limited to all other trademarks assigned to Releasor for security under the Original Assignment).
