## **TRADEMARK ASSIGNMENT AGREEMENT**

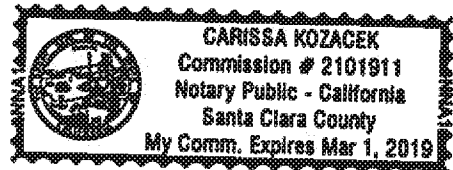
