ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS dated as of December 4, 2014 (“Trademark Assignment”), by and among Nature Acquisition LLC, a Delaware limited liability company (“Assignee”), Natrol, Inc., a Delaware corporation (“Natrol”), Natrol Holdings, Inc., a Delaware corporation (“N Holdings”), Natrol Acquisition Corp., a Delaware corporation (“N Acquisition”), Natrol Direct, Inc., a Delaware corporation (“N Direct”), Natrol Products, Inc., a Delaware corporation (“N Products”), Prolab Nutrition, Inc., a Connecticut corporation (“Prolab”), and Medical Research Institute, a California corporation (“MRI” and, together with Natrol, N Holdings, N Acquisition, N Direct, N Products, and Prolab, “Assignors,” and each individually, an “Assignor”). Assignors and Assignee are sometimes herein referred to collectively as the “Parties” and each individually as a “Party.”

WHEREAS, Assignors and Assignee have entered into that certain Asset Purchase Agreement dated as of November 10, 2014 (the “Purchase Agreement”);

WHEREAS, pursuant to the Purchase Agreement, Assignors have agreed to convey to Assignee their entire right, title, and interest in, to, and under the United States and foreign laws, the trademarks and trademark applications listed in the Assigned Trademarks Schedule attached hereto as Exhibit A, including all works of authorship disclosed and/or claimed in said trademark and trademark applications (collectively the “Assigned Trademarks”); and

WHEREAS, Assignors and Assignee wish to enter into this Trademark Assignment for the sole purpose of confirming and memorializing the applicable terms of the Purchase Agreement and making said terms of record in the U.S. Patent and Trademark Office and applicable foreign trademark offices.

TERMS AND CONDITIONS

NOW, THEREFORE, in consideration of the premises and mutual promises and covenants set forth herein and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignors and Assignee, intending to be legally bound, hereby agree to the following terms and conditions:

Assignors hereby sell, assign, set over, and transfer to Assignee, its successors and assigns, all of Assignors’ right, title, and interest in, to, and under any and all marks included in the Assigned Trademarks including, but not limited to: (a) the Assigned Trademarks themselves; (b) all goodwill associated therewith and symbolized thereby; (c) the registrations and applications therefor; (d) all issuances, renewals, extensions, restorations, and reversions thereof; (e) the right to sue for present, past, and future infringement or misappropriation and/or dilutions relating to any such marks; and (f) any other legal protection for any such Assigned Trademarks.

The Assigned Trademarks are being assigned, and such applications therefor are being transferred, along with all, or substantially all, of the portions of the particular Assignor’s business that primarily relates to such application. The right, title, and interest transferred hereto is to be held and enjoyed by Assignee and its successors and assigns as fully and exclusively as it

would have been held and enjoyed by Assignors had this assignment not been made.

Assignors hereby agree and undertake to execute, whenever requested by Assignee, all documents, and to take such further actions that are reasonably deemed necessary for Assignee's securing, prosecuting, and maintaining all of the Assigned Trademarks, with all actual costs being paid by Assignee, but without any further compensation to Assignors.

Assignor hereby authorizes and requests the U.S. Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the owner of the Assigned Trademarks.

Notwithstanding anything to the contrary herein, in the event of any conflict or inconsistency between the terms of this Trademark Assignment and the terms of the Purchase Agreement, the terms of the Purchase Agreement will prevail, and nothing contained herein shall be deemed to alter, modify, expand, or diminish the terms of the Purchase Agreement.


