TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release"), made as of March 22, 2016 by ROYAL BANK OF CANADA (the "Secured Party"), as collateral agent under the Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 8, 2014 (as amended, restated, supplemented, or otherwise modified from time to time, including all schedules thereto, the "Security Agreement"), Herculean US Holdings, Inc. ("Herculean"), Element Materials Technology Warren Inc. ("Element Warren"), Element Materials Technology Cincinnati Inc. ("Element Cincinnati") and Element Materials Technology Daleville, LLC ("Element Daleville" and, together with Herculean, Element Warren and Element Cincinnati, collectively, the "Initial Grantors"), have granted to the Secured Party a security interest in the Grantors' right, title, and interest in certain trademarks (the "Initial Grantor Trademarks") including those set forth on Schedule 1 hereto;

WHEREAS, pursuant to that certain Security Agreement Supplement for Trademarks dated as of February 19, 2015 (the "Supplement"), Environ Electronic Laboratories, Inc. ("Environ" and, together with the Initial Grantors, collectively, the "Grantors"), has granted to the Secured Party a security interest in Environ's right, title, and interest in certain trademarks (the "Environ Trademarks" and, together with the Initial Grantor Trademarks, collectively, the "Trademarks") including those set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded in the Assignment Branch of the United States Patent and Trademark Office at Reel: 5339, Frame: 0945 on August 8, 2014; and

WHEREAS, the Supplement was recorded in the Assignment Branch of the United States Patent and Trademark Office at Reel: 5463, Frame: 0480 on February 20, 2015.

NOW, THEREFORE, the Secured Party acknowledges the full performance of the Obligations (as such term is defined in the Security Agreement) as good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and hereby terminates, releases and discharges its security interest in the Collateral (as such term is defined in the Security Agreement), including, without limitation, the Trademarks, and re-assigns and releases to the applicable Grantor all right, title and interest that the Secured Party has in and to the Collateral, including, without limitation, the Trademarks. Any right, title or interest of the Secured Party in such Trademarks shall hereby cease and become void. The release set forth above is without recourse, representation, warranty (express or implied) or undertaking by the Secured Party to any Grantor.

The Secured Party hereby authorizes each Grantor, or such Grantor's authorized representative, to record this Release with the United States Patent Trademark Office and/or any other applicable governmental office or agency.

This Release shall be governed by and construed in accordance with the laws of the State of New York.


