RELEASE OF SECURITY INTEREST

WHEREAS, Citizens acknowledges and agrees that all of FuelBelt's obligations with respect to the Security Agreement and the Conditional Assignment have now been fully and completely satisfied and that the security interest granted has been and hereby is terminated; and


