TRADEMARK ASSIGNMENT

WHEREAS, Microbrush, Inc. NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of the amounts set forth in the Agreement, and other valuable and legally sufficient consideration, the receipt and legal sufficiency of which is hereby acknowledged, the U.S. Seller has sold, assigned and transferred, and by these presents does sell, assign and transfer unto the U.S. Buyer, the entire right, title and interest in and to the Trademarks, and in and to all of the goodwill of the business appurtenant thereto, together with all claims for damages by reason of infringement of same, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

AND, the U.S. Seller hereby requests the United States Commissioner of Patents and Trademarks (the "**Commissioner**"), as well as his or her foreign counterparts in the foreign jurisdictions which exercise authority over any of the Trademarks to record this Trademark Assignment. The U.S. Seller hereby further requests the Commissioner and his or her foreign counterparts to issue any and all registrations resulting from applications among the Trademarks or derived therefrom to the U.S. Buyer as assignee of the entire interest.

AND, the U.S. Seller, for itself and its successors and assigns, hereby covenants and agrees that at any time and from time to time forthwith upon the request of the U.S. Buyer, the U.S. Seller will, at its expense, do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered, all such further acts, deeds, instruments, transfers and assurances as may be reasonably required by the U.S. Buyer in order to assign, transfer, set over and convey unto, and vest in, the U.S. Buyer, its respective successors and assigns, any or all of the Trademarks, and to put the U.S. Buyer in actual possession and operating control thereof, free and clear of all liens, to assist the U.S. Buyer in exercising all rights with respect thereto and to assure the U.S. Buyer of the full benefits thereof.

This Trademark Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of the U.S. Seller and the U.S. Buyer. This Trademark Assignment shall not confer any rights or remedies upon any person other than the parties hereto, and their respective successors and assigns.

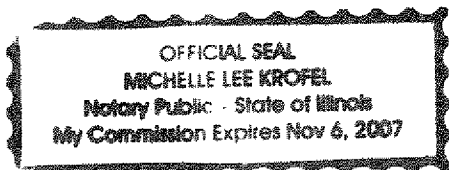
