## RELEASE OF GRANT OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 28, 2012 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4869, Frame 0794, Baker & Taylor, LLC, a Delaware limited liability company (formerly known as Baker & Taylor, Inc., a Delaware corporation and successor in interest to YBP Library Services, Inc., a New Hampshire corporation and BWI Acquisition, LLC, a Delaware limited liability company) (collectively, "Releasees"), granted to Wells Fargo Bank, National Association (successor in interest to General Electric Capital Corporation), in its capacity as Collateral Agent ("Releasor"), a lien on and security interest in and to all of the right title and interest of such Releasees, in, to and under all of its Trademarks and Trademark Licenses and all proceeds thereof, including those listed in Schedule I hereto (the "Released Trademark Collateral"); and

WHEREAS, Releasor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Trademark Collateral and termination of the Trademark Security Agreement.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

2. Release of Security Interest. Releasor hereby, without any representation and warranty, (i) terminates, releases, relinquishes and discharges fully its security interest in and to the Released Trademark Collateral, and the goodwill associated therewith, and terminates the Trademark Security Agreement., (ii) waives and relinquishes all its rights, powers, privileges and remedies with respect to the Released Trademark Collateral, and the goodwill associated therewith, and (iii) reassigns, grants, and conveys to the Releasees any and all right, title and interest it has in the Released Trademark Collateral, and the goodwill associated therewith.

3. Filing of this Release. Releasees, or their designee, may record this Release of Grant of Security Interest --Trademarks in the USPTO and in any other offices as may be necessary to carry out the intention of this release, and to the extent applicable, the parties hereto authorize and request that the USPTO record this release of security interest.

4. Governing Law. This Release of Grant of Security Interest --Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.

5. Execution. Delivery of an executed signature page to this Release of Grant of Security Interest --Trademarks by facsimile or electronic transmission (including .pdf file) shall be effective as delivery of an original signature.





