- 3. Filing of this Release. Releasees, or their designee, may record this Release of Grant of Security Interest -- Trademarks in the USPTO and in any other offices as may be necessary to carry out the intention of this release, and to the extent applicable, the parties hereto authorize and request that the USPTO record this release of security interest.
- 4. Governing Law. This Release of Grant of Security Interest -- Trademarks shall be governed by, and construed in accordance with, the laws of the State of New York.
- 5. Execution. Delivery of an executed signature page to this Release of Grant of Security Interest -- Trademarks by facsimile or electronic transmission (including .pdf file) shall be effective as delivery of an original signature.
