**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of April 29, 2016, is made by General Electric Company as successor in interest by merger to GENERAL ELECTRIC CAPITAL CORPORATION ("**GE Capital**"), as administrative agent (in such capacity, together with its successors and permitted assigns, the "**Administrative Agent**") for the Lenders (as defined in the Credit Agreement referred to below). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement.

**WHEREAS**, in connection with that certain Credit Agreement, dated as of March 31, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), by and among CWD, LLC (d/b/a Centric Parts) (the "**Borrower**"), the other Credit Parties party thereto, the Lenders and the L/C Issuer from time to time party thereto, the Revolver Agent and Administrative Agent, the Lenders and L/C Issuer previously made extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

**WHEREAS**, each Guarantor previously agreed, pursuant to the Guaranty and Security Agreement in favor of the Secured Parties, to guarantee the Obligations of the Borrower;

**WHEREAS**, in connection with the Credit Agreement, Guaranty and Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Credit Parties granted security interests in certain intellectual property owned by the Credit Parties, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and


**WHEREAS**, the Security Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW THEREFORE**, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Intellectual Property Collateral to the Credit Parties. The Administrative Agent agrees, at the expense of the Credit Parties, to cooperate with the Credit Parties and to provide the Credit Parties with the information and additional authorization reasonably required to effect the release of the Administrative Agent's security interests in the Intellectual Property Collateral.
