ASSET PURCHASE AGREEMENT

As consideration for the sale, transfer, and conveyance of the Assets by Seller, Purchaser agrees to (a) pay at the Closing, in immediately available funds (the "<u>Closing Consideration</u>"); and (b) assume the liabilities and obligations of the Seller identified as <u>Assumed Liabilities</u> on Schedule 1.
- 3. <u>Liabilities and Obligations Not Assumed</u>. Purchaser shall not assume or become obligated in any way to pay any liabilities, debts or obligations of Seller whatsoever except for the Assumed Liabilities, including but not limited to any liabilities or obligations now or hereafter arising from Seller's business activities that took place prior to the Closing.
- 4. <u>Representations and Warranties of Seller</u>. Except as to Seller's representations and warranties expressly provided below, the Assets are being sold "as is," and "where is" and "with all faults", with no express or implied representation and warranties of any kind, nature,


