WHEREAS, pursuant to that certain Amended and Restated Securities Purchase Agreement dated May 6, 2016 (as at any time further amended, restated, supplemented or otherwise modified, the "Securities Purchase Agreement"), by and among NB Parent Company Inc., a Delaware corporation ("Holdings"), NB Products Inc., a Delaware corporation (the "Company"), the Guarantors named therein, each of the Purchasers named therein, the other Noteholders from time to time party thereto and the Administrative Agent, the Purchasers have agreed to purchase the Purchased Securities subject to the terms and conditions set forth therein;

WHEREAS, pursuant to that certain Joinder Agreement, Second Amendment and Supplement to Pledge and Security Agreement dated as of May 6, 2016 (as at any time amended, restated, supplemented or otherwise modified, the "Joinder Agreement"), by and among the Company, Holdings, Rooster, Rooster Services, LLC, a Texas limited liability company, the other Guarantors party thereto and the Administrative Agent, which Joinder Agreement amends and supplements that certain Pledge and Security Agreement dated as of February 24, 2015 (as at any time further amended, restated, supplemented or otherwise modified, the "Security Agreement"), by and among Company, Holdings, the other Guarantors party thereto and the Administrative Agent, each Grantor has agreed to, among other things, grant to Administrative Agent, for the benefit of itself and the Secured Parties, a continuing security interest in all of such Grantor's intellectual property, including, without limitation, all of such Grantor's trademarks and related rights, to secure all obligations and liabilities owing from time to time from any Grantor to the Purchasers under the Securities Purchase Agreement, the Security Agreement, or otherwise; and

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce Purchasers to purchase the Purchased Securities pursuant to the Securities Purchase Agreement, each Grantor agrees with Administrative Agent, for the benefit of the Secured Parties, as follows:

- 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings given such terms or provided by reference in the Security Agreement.
- 2. <u>Notice of Grant of Security Interest</u>. Each Grantor hereby assigns and grants to Administrative Agent, to secure the prompt and complete payment and performance of all Obligations, a security interest in all of its right, title and interest in, to and under such Grantor's Trademarks, including, without limitation, all trademarks (including service marks), trade names, trade dress, and trade styles and

the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing listed on <u>Schedule A</u> hereto.

- 3. <u>Purpose</u>. This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Administrative Agent in connection with the Security Agreement and is expressly subject to the terms and conditions thereof.
