TRADEMARK SECURITY AGREEMENT

This Agreement is made as of May 26, 2016 by and among Medica Health Plans, a Minnesota non-profit corporation ("MHP"), Medica Insurance Company, a Minnesota corporation ("MIC"; together with MHP, collectively, the "Debtors"), and Wells Fargo Bank, National Association, a national banking association (the "Secured Party").

Pursuant to a Credit Agreement (together with all amendments, modifications and restatements of such agreement, the "Credit Agreement") of even date herewith between the Debtors and the Secured Party, the Secured Party has agreed to make advances to the Debtors.

As a condition to making any advance under the Credit Agreement, the Lender required the execution and delivery by the Debtors of a Security Agreement (together with all amendments, modifications and restatements of such Agreement, the "Security Agreement") of even date herewith, pursuant to which the Debtors granted the Secured Party a security interest in substantially all of each Debtor's personal property.

Pursuant to the Security Agreement, the Debtors are required to execute and deliver this Agreement to the Secured Party.

ACCORDINGLY, in consideration of the mutual covenants contained in the Credit Agreement, the Security Agreement and this Agreement, the parties hereby agree as follows:

1. Definitions.

Terms defined in or pursuant to the Security Agreement and not otherwise defined herein shall have the meanings given them in or pursuant to the Security Agreement. In addition, the following terms have the meanings set forth below:

"Trademark Collateral" means all right, title and interest of each Debtor in and to the following, in each case whether now owned or hereafter acquired or arising:

- (i) All Trademarks, including the Specified Trademarks
- (ii) All accounts and other rights to payment (including but not limited to payments of royalties) arising from or relating to any Trademark.
- (iii) All rights to recover for all past, present, and future infringements, dilutions, preissuance recoveries and other violations of Trademarks.
- (iv) All present and future license agreements with respect to the Trademarks.
- (v) All proceeds of any and all of the foregoing.

"Specified Trademark" means each of the Trademarks listed on <u>Schedule A</u>, together with all divisions, foreign counterparts, renewals and extensions thereof.

"Trademark" means any trademark, service mark, collective membership mark, and registration or application for registration of any trademark, service mark or collective membership mark, together with the goodwill associated therewith.

2. Grant of Security Interest.

In order to secure the Obligations, each Debtor hereby confirms and acknowledges that it has granted and created (and, to the extent not previously granted under the Security Agreement, does hereby irrevocably grant and create in favor of the Secured Party) a security interest in the Trademark Collateral.

3. Representations and Warranties.

Each Debtor represents and warrants that such Debtor owns each of the Specified Trademarks stated to be owned by it on <u>Schedule A</u>, free and clear of any Lien other than Permitted Liens.

4. General Rights and Obligations.

Except as expressly set forth herein, the rights and obligations of each Debtor and the Secured Party with respect to the Trademark Collateral shall in all respects be governed by the Credit Agreement and the Security Agreement, the terms of which are incorporated as fully as if set forth at length herein.
