TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), is made and entered into as of the 28th day of March, 2016, (the "Effective Date"), by and between AWI LICENSING COMPANY, a Delaware corporation ("AWI Licensing"), and AFI LICENSING LLC, a Delaware limited liability company and wholly owned subsidiary of AWI Licensing ("AFI Licensing"). Each of the parties hereto are referred to together as the "Parties" and individually as a "Party". Capitalized terms used herein and not otherwise defined shall have the respective meanings ascribed to such terms in the Separation and Distribution Agreement.

WHEREAS, Armstrong World Industries, Inc., a Pennsylvania corporation and the sole stockholder of AFI Licensing ("AWI"), has adopted and approved a Plan of Division (the "Plan of Division") and entered into that certain Separation and Distribution Agreement (the "Separation and Distribution Agreement"), dated as of March 11, 2016, by and between AWI and Armstrong Flooring, Inc., a Delaware corporation ("AFI"), to separate AWI's flooring business from its ceilings (building products) business, creating two independent industry-leading publicly traded companies (the "Separation");

WHEREAS, AWI Licensing is the sole member of AFI Licensing;

WHEREAS, AWI Licensing and AFI Licensing entered into a Contribution Agreement ("Contribution Agreement") in order to effect the contribution, transfer and assignment by AWI Licensing to AFI Licensing of all of AWI Licensing's right, title and interest in and to the AFI Intellectual Property, including all rights and remedies against past, present, and future infringement or other violation thereof and excluding, for clarity, the AWI Name and AWI Marks (as each is defined in the Separation and Distribution Agreement) (collectively, the "AFI IP") (the "IP Contribution"); and

WHEREAS, in contemplation of the Contribution Agreement, Assignor has agreed to assign, transfer and convey to Assignee all of Assignor's right, title, and interest in and to the AFI IP, including the trademark applications and registrations set forth on set forth on Schedule A hereto (collectively, the "Assigned Trademarks").

NOW, THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance. Assignor does hereby assign, transfer and convey to Assignee all of Assignor's right, title and interest in and to the Assigned Trademarks, together with the goodwill symbolized by any of the foregoing and all rights and remedies against past, present, and future infringement or other violation thereof.

2. Recordation. The Parties agree to reasonably cooperate with each other with respect to preparing instruments to record Assignee as the owner of the Assigned Trademarks in the United States Patent and Trademark Office and any other applicable foreign Governmental Authority or registrar, in each case in form and substance in accordance with the applicable Laws of the jurisdiction to which such instrument pertains, and Assignee shall have the right to record such instrument with the applicable Governmental Authority or registrar. Notwithstanding anything to the contrary in any such instrument, to the extent of any conflict or inconsistency between this Assignment and such instrument, this Assignment shall control. For clarity and without limiting the foregoing, any such instrument may or may not refer to this Assignment, the Contribution Agreement, the Separation and Distribution Agreement or any other Ancillary Agreement or include disclaimers, limitations or exceptions with respect to the Assigned Trademarks or the assignments thereof and may be dated as of, before or after the Effective Date.

3. Disclaimer of Warranties. Except as expressly set forth herein, the Parties acknowledge and agree that the Assigned Trademarks are provided as-is, that the Assignee assumes all risks and Liability arising from or relating to its use of and reliance upon the Assigned Trademarks and each Party makes no representation or warranty with respect thereto. EXCEPT AS EXPRESSLY SET FORTH HEREIN, EACH PARTY HEREBY EXPRESSLY DISCLAIMS ALL REPRESENTATIONS AND WARRANTIES REGARDING THE ASSIGNED TRADEMARKS, WHETHER EXPRESS OR IMPLIED, INCLUDING ANY REPRESENTATION OR WARRANTY IN REGARD TO QUALITY, PERFORMANCE, NONINFRINGEMENT, COMMERCIAL UTILITY, MERCHANTABILITY OR FITNESS OF ASSIGNED TRADEMARKS FOR A PARTICULAR PURPOSE.

4. Further Assurances. From and after the date of this Assignment, each Party, at the request of any other Party, shall take all such action and deliver all such documents as shall be reasonably necessary or appropriate to effect the assignment as set forth in this Agreement and otherwise enable each Party to enjoy the benefits contemplated by this Assignment.

5. Entire Agreement. This Assignment, together with the Contribution Agreement, Separation and Distribution Agreement and the other agreements being entered into in connection with the transactions contemplated thereby, constitutes the sole and entire agreement of the Parties to this Assignment with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, representations and warranties and agreements, both written and oral, with respect to such subject matter.

6. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the Parties hereto and their respective successors and permitted assigns.

7. No Third-Party Beneficiaries. This Assignment is for the sole benefit of the Parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other person any legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this Assignment.

8. Headings. The headings in this Assignment are for reference only and shall not affect the interpretation of this Assignment.

9. Amendment and Modification; Waiver. This Assignment may only be amended, modified or supplemented by an agreement in writing signed by each of the Parties. No waiver by any Party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the Party so waiving. Except as otherwise set forth in this Assignment, no failure to exercise, or delay in exercising, any rights, remedy, power or privilege arising from this Assignment shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

10. Governing Law; Submission to Jurisdiction. This Assignment is made under, and shall be construed and enforced in accordance with, the laws of the state of Delaware, without giving effect to principles of conflicts of law.

11. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
