WHEREAS, Grantor has satisfied the terms of the Credit and Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

This Release is given and delivered by Administrative Agent without recourse to Administrative Agent and shall be filed or recorded at the sole cost and expense of Grantor.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
