## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of 23 May, 2016 (this "Agreement"), is made by the signatory hereto indicated as a "Grantor" (the "Grantor") in favor of UBS AG, STAMFORD BRANCH, as Security Trustee for the Secured Parties (in such capacity and together with its successors and assigns in such capacity, the "Security Trustee").

WHEREAS, pursuant to that certain Syndicated Facility Agreement dated as of October 20, 2014 by and among Aristocrat Leisure Limited ACN 002 818 368, a corporation registered in New South Wales ("Holdings"), Aristocrat International Pty Ltd ACN 000 148 158, a corporation registered in New South Wales, Aristocrat Technologies Australia Pty Limited ACN 001 660 715, a corporation registered in New South Wales, Aristocrat Technologies, Inc., a Nevada corporation, and prior to the consummation of the Merger, Tonkor Enterprises, Inc., a Tennessee corporation, and upon consummation of the Merger, Video Gaming Technologies, Inc., a Tennessee corporation (collectively, the "Borrowers"), the banks and other financial institutions or entities from time to time party thereto (the "Lenders"), UBS AG, Stamford Branch, as administrative agent for the Term Facility and as Security Trustee and UBS AG, Australia Branch as administrative agent for the Revolving Facility and as Issuing Lender (as the same may hereafter be amended, restated, supplemented or otherwise modified from time to time, the "Syndicated Facility Agreement"), the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and conditions set forth therein, and the Secured Parties have severally agreed to provide the Cash Management Obligations and Specified Hedge Agreements to the Loan Parties; and

WHEREAS, as a condition precedent to the obligation of the Lenders to make their respective extension of credit to the Borrowers under the Syndicated Facility Agreement and to induce the Secured Parties to provide the Cash Management Obligations and Specified Hedge Agreements, the Grantor entered into a General Security Deed dated as of October 20, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "General Security Deed") between, among others, each of the Grantor and the Security Trustee, pursuant to which the Grantor granted to the Security Trustee, for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined below);

WHEREAS, the Grantor agreed to execute this Agreement in order to record the security interest with respect to the Trademark Collateral granted to the Security Trustee for the benefit of the Secured Parties with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantor hereby agrees with the Security Trustee as follows:

### SECTION 1. Defined Terms

Capitalized terms used but not defined herein shall have the respective meanings given thereto in the General Security Deed, and if not defined therein, shall have the respective meanings given thereto in the Syndicated Facility Agreement.

## SECTION 2. Grant of Security Interest

**SECTION 2.1 Grant of Security.** The Grantor hereby grants to the Security Trustee, for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to the following property now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral") as collateral security for the payment or performance, as the case may be (whether at the stated maturity, by acceleration or otherwise), of the Secured Obligations:

(i) those trademarks and trademark applications listed in Schedule A (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of said Act has been filed), and (ii) the right to obtain all renewals thereof, (iii) rights to sue at law or in equity for any infringement or other violations thereof, (iv) Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto, and (v) other rights of any kind accruing thereunder or pertaining thereto throughout the world.

**SECTION 2.2 Certain Limited Exclusions.** Notwithstanding anything herein to the contrary, in no event shall the Trademark Collateral include or the security interest granted under Section 2.1 hereof attach to any "intent-to-use" application for registration of a Trademark filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, prior to the filing of a "Statement of Use" pursuant to Section 1(d) of the Lanham Act or an "Amendment to Allege Use" pursuant to Section 1(c) of the Lanham Act with respect thereto, solely to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such application or any registration that issues from such intent-to-use application under applicable federal law.

## SECTION 3. General Security Deed

The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Security Trustee for the Secured Parties pursuant to the General Security Deed, and the Grantor hereby acknowledges and affirms that the rights and remedies of the Security Trustee with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the General Security Deed, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement (other than Section 4 of this Agreement) is deemed to conflict with the General Security Deed, the provisions of the General Security Deed shall control.

## SECTION 4. Governing Law

THIS AGREEMENT (OTHER THAN SECTION 3) AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT (OTHER THAN SECTION 3) SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN

ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAWS TO THE EXTENT THAT THE SAME ARE NOT MANDATORILY APPLICABLE BY STATUTE AND THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION WOULD BE REQUIRED THEREBY.

**SECTION 5. Counterparts**

This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts (including by telecopy or electronic (e.g., "pdf") transmission), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

**SECTION 6. Capacity of the Security Trustee**




