TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of June 13, 2016, is made by Credit Suisse AG, Cayman Islands Branch, as collateral agent (in such capacity, the "Collateral Agent"), in favor of Flint Trading, Inc., a North Carolina corporation, Ennis Paint, Inc., a Texas corporation, Eberle Design, Inc., an Arizona corporation, Reno A&E, LLC, a Delaware limited liability company (each, a "Pledgor" and, collectively, the "Pledgors"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Collateral Agreement (as defined below). Notwithstanding the foregoing, for the purposes of this Termination, "Trademark Collateral" shall have the meaning assigned to such term in the Trademark Security Agreement (as defined below) and shall include, without limitation, those Trademark registrations and Trademark applications listed on Schedule 1 attached hereto.

WHEREAS, pursuant to that (i) certain Second Lien Guarantee and Collateral Agreement, dated as of March 31, 2014 (as it may be amended, restated, supplemented, waived or otherwise modified from time to time, the "Collateral Agreement") between the Pledgors, the other pledgors party thereto and the Collateral Agent and (ii) certain Trademark Security Agreement, dated as of March 31, 2014 (the "Trademark Security Agreement") executed by the Pledgors in favor of the Collateral Agent, the Pledgors granted to the Collateral Agent a security interest in and continuing lien on all of the Pledgors' right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the security interest in the Trademark Collateral pledged and granted by the Pledgors to the Collateral Agent under the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on April 15, 2014, at Reel 005260, and Frame 0590; and

WHEREAS, the Collateral Agent has agreed to terminate, release and discharge its security interest and lien on all of the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Pledgors secured by the Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreement, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent hereby terminates, releases and discharges all of its mortgages, liens, and security interests in all of the Pledgors' right, title and interest in, to and under the Trademark Collateral, including all goodwill associated with the Trademark Collateral, and hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in the Trademark Collateral to each Pledgor, as applicable.

2. The Collateral Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.




