TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of June 28, 2016 by **SILICON VALLEY BANK**, as Administrative Agent (the "*Assignee*"), in favor of **BLOGWIRE HUNGARY SZELLEMI ALKOTAST HASZNOSITO KFT.**, a limited liability company organized under the laws of Hungary ("*Blogwire*") and **GAWKER MEDIA LLC**, a Delaware limited liability company ("*Gawker*", together with Blogwire, individually, a "*Grantor*", and collectively, the "*Grantors*").

WHEREAS, Blogwire executed and delivered an Intellectual Property Security Agreement dated as of September 24, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, "*2012 Trademark Agreement*"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on January 24, 2013, at Reel 4948, Frame 0634;

WHEREAS, Gawker executed and delivered a First Supplement to Intellectual Property Security Agreement dated as of January 21, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, "*First Supplement*", together with the 2012 Trademark Agreement, collectively, the "*Grants*"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the *USPTO* on January 25, 2016, at Reel 5715, Frame 0344;

WHEREAS, the Grantors have requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the trademarks and trademark applications described in the Grants (collectively, the "*Marks*") as herein provided; and

WHEREAS, the Grantors have requested that the Assignee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grants and releases, terminates and discharges all liens and security interests in each Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those Marks identified in Schedule I hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any Grantors', or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
