## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (the “*Release*”) dated June 21, 2016, is made by Barclays Bank PLC, as collateral agent (in such capacity, the “*Collateral Agent*”) for the Secured Parties in favor of Newsday LLC, a Delaware limited liability company (“*Newsday*”), and Newsday Holdings LLC, a Delaware limited liability company (together with Newsday, the “*Grantors*”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Security Agreement (as defined below), or if not defined therein, as defined in the Credit Agreement (as defined below).

WHEREAS, the Grantors entered into that certain Credit Agreement, dated as of October 12, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”) among Newsday, as the borrower, CSC Holdings, LLC, a Delaware limited liability company, the Lenders from time to time party thereto and Barclays Bank PLC, as Administrative Agent and the Collateral Agent;

WHEREAS, as a condition precedent to the making of the Term Loans by the Lenders under the Credit Agreement, each Grantor executed and delivered that certain Security Agreement, dated as of October 12, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”) made by the Grantors to the Collateral Agent;

WHEREAS, under the terms of the Security Agreement, the Grantors granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to certain intellectual property of the Grantors and executed and delivered that certain Intellectual Property Security Agreement, dated as of October 12, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Intellectual Property Security Agreement*”), by the Grantors in favor of the Collateral Agent;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on November 8, 2012 at Reel 29275 and Frame 222 with respect to patents and at Reel 4896 and Frame 0540 with respect to trademarks; and

WHEREAS, in accordance with the provisions of the Credit Agreement and the Intellectual Property Security Agreement, the indebtedness under the Credit Agreement has been paid in full, and the Collateral Agent now desires to release its security interest in and to the Collateral (as defined in the Intellectual Property Security Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby releases, without representation or warranty of any kind, its security interest in the Collateral, including the Collateral listed on Schedules A, B and C, granted to it pursuant to the Intellectual Property Security Agreement.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 3. Execution in Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
