RELEASE OF SECURITY INTEREST

IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of July 14, 2016, is made by ConnectOne Bank, previously named North Jersey Community Bank (the "Bank"), under the Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement).

WHEREAS, in connection with that certain Security Agreement, dated as of September 13, 2012 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith or in connection with prior versions thereof, the Security Agreement), between Etonic Holdings, LLC (the "Grantor") and the Bank, the Bank made credit extensions to the Borrowers:

WHEREAS, in connection with the Security Agreement, and pursuant to those certain agreements described on Annex I and Annex II attached hereto (collectively, the "Security Agreements"), the Grantor granted security interests in certain intellectual property owned by the Grantor including those listed on Annex I and Annex II attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I and Annex II hereto;

NOW THEREFORE, the Bank hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Security Agreement and the Bank hereby reassigns any and all such right, title and interest (if any) that the Bank may have in the Intellectual Property Collateral to the Grantor.


